Rest assured we are fully operational to answer all calls for service in the safest manner possible during these unprecedented times. With this in mind, our level of community engagement will be tailored with social distancing in mind to keep all parties safe from the transmission of COVID-19. - 2. Priority Contribute to Safe Roads
 - a. 10 Impaired drivers were charged in your communities.
 - b. 3 Road safety presentation online and in school were completed to high school students on driving safety in school zones.
 - c. 17 Motor Vehicle Collisions
- 3. Priority Crime Reduction (Rural property crime)
 - a. 214 pro-active Rural Crime Patrols to Hussar, Bassano, Gem, Rosemary, Counties of Newell and Wheatland.
 - b. 69 Hot spot Patrols* Based on our Intelligence program from last year we have identified hot spot areas where Copper thefts is prevalent and have increased patrols in these designated areas.
 - c. We had 2 break and enters into businesses in Hussar during this quarter where our SOC's had a firearm. Both SOC's have been identified through our intelligence program and we are currently pending DNA analysis from blood left at scene to complete investigation and chares suspects.
- **4.** High Priority Calls.
 - a. 5 Sudden Deaths
 - b. 3 MHA transports
 - c. 7 Charges laid in Person crimes * Defined by Assault, Sexual Assault, Harassment. Utter threats
- *Update: since the easing of restrictions by the Alberta Government of Covid-19, we have seen an increase in calls for service this quarter from last quarter's 200 calls to 396 this quarter. We have noted a slight decrease in person's crimes, but an uptick in Break and enters in our rural areas businesses. Calls for service for copper theft files have greatly decreased, and Bassano RCMP is more focused on helping to curve crime in other areas.
