

**BYLAW #530-20
VILLAGE OF HUSSAR**

A BYLAW OF THE VILLAGE OF HUSSAR IN THE PROVINCE OF ALBERTA TO AMEND BYLAW #512-16

WHEREAS, the Village of Hussar has adopted Bylaw #512-16 pursuant to the Municipal Government Act, RSA Chapter M-26,

AND WHEREAS, Council deems it necessary to amend Bylaw #512-16,

NOW THEREFORE, the Council of the Village of Hussar duly assembled hereby amends Bylaw #512-16 as follows:

1. In Section 4.5 add the words "1 alternate" after "member" to Canadian Badlands, Drumheller and District Solid Waste Management, Hussar Rural Fire Association, Wheatland Family & Community Support Services, Wheatland & District Emergency Medical Services Association, Wildrose Community Futures

Add the words:

"Intermunicipal Development Plan Committee (IDP) (2 member, 1 alternate)
Palliser Regional Municipal Services (1 member, 1 alternate)
Wheatland Regional Emergency Advisory Committee (1 member, 1 alternate)
Wheatland Regional Partnership (3 members)" and alphabetize accordingly:


- a. Canadian Badlands (1 member, 1 alternate)
 - b. Cemetery Board (1 member)
 - c. Drumheller and District Solid Waste Management (1 member, 1 alternate)
 - d. Hussar Municipal Library Board (1 member)
 - e. Hussar Rural Fire Association (1 member, 1 alternate)
 - (f) Intermunicipal Development Plan Committee (IDP) (2 member, 1 alternate)
 - (g) Palliser Regional Municipal Services (1 member, 1 alternate)
 - f. (h) Wheatland County Assessment Review Board (1 public member)
 - g. (i) Wheatland Family & Community Support Services (1 member, 1 alternate)
 - h. (j) Wheatland Regional Corporation (1 member, 1 alternate)
 - (k) Wheatland Regional Emergency Advisory Committee (1 member, 1 alternate)
 - (l) Wheatland Regional Partnership (3 members)
 - i. (m) Wheatland & District Emergency Medical Services Association (1 member, 1 alternate)
 - j. (n) Wildrose Community Futures (1 member, 1 alternate)
 - k. (o) Any additional boards and committees
2. In Section 4.7 remove the words "Disaster Services" and replace with "Emergency Management"
- 4.7.** The following position appointments shall be made:
- a. Director of ~~Disaster Services~~ Emergency Management
 - b. Deputy Director of ~~Disaster Services~~ Emergency Management
